Both the high school and the Alumni Association continue to go strong. The high school is one of the best schools in New York City, and is also one of the most sought after. Its students receive accolade upon accolade. Seniors receive over millions of dollars of scholarships to college upon graduation. Many of those same seniors go on to attend Ivy-league schools. Townsend Harris continues to be a leader in community service; in fact, Lisa Liu, a current student, was a Queens Quality of Life semifinalist last year for her work advocating volunteerism in local parks. School athletics remain a vital aspect of the students' lives. Girls' swimming, girls' fencing, boys' bowling - these are only three examples of current teams that had great success this past year.

There have been many school events during the past year in which alumni participated. Over 30 alumni served as judges at the high school's SING! competition. We once again provided speakers for the Townsend Harris Career Day, where many of us returned to the school to share our experiences from the workplace. Kevin Kim of the Class of 1988 was the keynote speaker at October's Founders' Day ceremony at the high school.

Last Fall, we had another of our cherished Hall of Fame ceremonies. We honored another group of extremely distinguished men who pioneered the reopening of the high school in the early 1980s. This year's ceremony was especially unique in that the ceremony was held as a cocktail reception on the campus of Baruch College on 23rd Street in Manhattan, where the school was situated for most of the early half of the 20th century. The turnout was remarkable and the celebration memorable. On the fundraising front, we continue to be quite successful raising funds for the Townsend Harris Forever! campaign. We were able to increase the endowments for the faculty development and community service funds (amongst others). Through several generous contributions, we were also able to purchase new classical language textbooks, procure new library equipment for the Malcolm G. Largmann library and finance advanced courses in the study of Hebrew. Of course, our job is not done; there is still much to do. # DRAMATIC GIFT TOPS GREAT YEAR FOR ALUMNI ASSOCIATION FUND RAISING

uring the first eleven months of 2007, the Alumni Association fund raising efforts achieved outstanding results. In addition to the generous annual scholarship fund contributions (the Alumni Association provides more than \$110,000 in scholarships to Townsend Harris seniors each year), and the donations which accompanied dues payments, there were some dramatic developments. Early in the year, the Keren Keshet Fund, which was established by the late Sanford C. Bernstein '42, agreed to increase its annual grant for teaching Hebrew from \$20,000 a year to \$25,000 a year.

In September, in response to an appeal, the Jerome Levy Foundation, which was funded by the late Leon Levy '42, wrote these welcome words: "The Trustees of the Jerome Levy Foundation have approved a renewal of its annual grant of \$25,000 to the Townsend Harris Alumni Association, Inc."

In December, the Henry Nias Foundation increased its contribution to \$50,000 for 2007 for annual scholarships.

#### TREASURY REPORT

The finances of the Alumni Association continue to be strong. We currently hold over \$1.7 million in cash and investments, and pledged money brings the total to well over \$2.5 million.

The finance committee of the Board of Directors monitors the investment portfolio, which currently consists of a balance of cash, certificates of deposits and balanced mutual funds. The Board of Directors reviews the financial position of the Alumni Association on a monthly basis, and any alumnus may request a report detailing this position.

The largest source of funds continues to be contributions — many of which are for endowments in which only the income is to be expended. During our last fiscal year (September 1, 2006 through August 31, 2007), the Alumni Association received \$190,000 of contributions from its members. Membership dues provide much of the source for operating expenses of managing the day-to-day affairs of the organization.

Expenditures include both program and administrative costs; the largest item that we disburse cash for is the many scholarships and awards presented by the Alumni Association each year. In this fiscal year, we have disbursed over \$110,000 in such scholarships and awards. We also provide a significant amount of funding for various programs at the high school, including faculty development, purchase of textbooks, coursework in Hebrew for students and procurement of library equipment. In this fiscal year, we have disbursed over \$50,000 for these items. Administrative expenses include general office expenses, postage and printing for announcements and alumni publications, refreshments for the annual meeting and maintenance of our website, www.thaa.org.

# ·AT THE SCHOOL ·

#### At the High School...

- ◆ The Ephebic Oath continues to be the guiding credo for expectations, values and traditions at Townsend Harris. Community service is a strong indicator of the school's commitment to the Ephebic Oath. Last Spring, over 225 students were inducted into Archon, a national honor society whose members perform over 80 hours of community service annually while maintaining high academic standards.
- Several students and faculty will visit Greece and Italy in February, 2008. In Athens, students will see the Sanctuary of Aglaurus, a cave on the north slope of the Acropolis where the Ephebic Oath was first taken over two thousand years ago by young Athenians entering adulthood.
- According to Department of Education statistics, Townsend Harris was the most popular, non-specialized public high school in New York City in 2007. More 8th graders selected Harris as their first choice than any other high school in New York City.
- ◆ Economics students had outstanding performance (99.5% passed) on the Wise Financial Literacy Certification test. 16 students scored 95, or higher, and were named Financial Literacy Scholars. Two students achieved perfect scores.
- ♦ Over 430 students participated in this year's National Latin Examination and Townsend Harris achieved outstanding results: 158 students achieved Summa Cum Laude; 141 students achieved Maxima Cum Laude; 53 achieved Magna Cum Laude, and 36 achieved Cum Laude. This rigorous examination is taken by more than 134,000 students representing all 50 states and 13 foreign countries. Townsend Harris students' results were better than any other school worldwide.

- ◆ The school's New York State Regents results were absolutely impressive with 100% of Townsend Harris students who took the French, Spanish, Japanese and Latin Examinations receiving passing grades.
- ♦ With the mastery of the Hebrew block print alphabet and script, beginners are already doing oral and written communication on personal identity items in the target language. Advanced students are accelerating their skills through a very modern text with dialogs, literary and cultural readings, current events and lots of enjoyable activities. They all learned about the recent holidays and are looking forward to the joyous celebration of Chanukah.
- Townsend Harris dominated the Quality of Life Competition, winning two of the top three prizes.
- ◆ Harrisites dominated this year's International Science and Engineering Fair (ISEF). Each of the students who participated medaled in their event: Markrete Krikorian 4th place, Chemistry; Bushra Wazed 3rd place, Animal Behavior; and Ben Aronowicz, Warren Cheng, and Erin Zeqja 3rd place, Physics. These students competed against 1500 students from 40 countries. All students who compete at ISEF had previously won in their category at regional competitions.
- ◆ The Robotics program that started last year is off to a great start with students capturing medals in the Science Olympiad Robotics NYC regional competition, and placing 9th in the statewide event. Students are planning to enter the First Robotics Competition. The school would appreciate any alumni expertise in robotics, or programming in Java, as we undertake this new venture. In ad-

- ◆ The school boasts over 100 students this year who are members of Mu Alpha Theta a national math honor society that recognizes the achievement of juniors and seniors with a 93 or better overall math average (and who have finished Math B). These Mu Alpha Theta students volunteer their time once a week to tutor their peers in any math subject during lunch bands or before/after school.
- ◆ On the athletics' front, the school's teams have had some great victories, including the girl's swim team being again undefeated, the boys' cross country team sophomores taking 1st place in Queens, and the girls' cross country team capturing 1st place in the Mayor's Cup. The PSAL Heisman Award, given each year to the student who is best in his or her athletics field was awarded to four students: Devotia Moore (Cross-Country), Maureen Mc Cluskey (Swimming), Amy Feng (Fencing) and Linda Thai (Handball).
- ◆ In a U.S. News and World Report study, Townsend Harris High School was named the 45th best high school in the entire country!
- ◆ Townsend Harris was the National Champion of the Youth About Business Summer Business Camp, the first school from New York to achieve that honor.
- In the most recent "School Report Card," performed by the NYC Department of Education on all schools, Townsend Harris was one of the few school which received an "A" rating!

### Message from Thomas Cunningham, Principal

Dear Alumni:

Welcome to another exciting Fall term at Townsend Harris High School. We have much to celebrate this year. Townsend Harris High School continues to be an academic institution of excellence in New York City and in the country. This year over 700 students are enrolled in AP classes. This past year, once again, our school achieved the highest passing percentage on Regents exams, the highest rate of attendance, and the highest graduation rate of any high school in New York City. I know that you join me in congratulating both our outstanding staff and student body on these achievements.

We have many activities that define our Humanities program at Townsend Harris High School. One of them is the Election Simulation which is of special importance this year because the 2007 Election Simulation will determine who will be the New York State Democratic and Republican representatives at both national nominating conventions this summer. On Founders Day, October 26th, we celebrated and practiced those values that are evident in our community service program and are enshrined in the Ephebic Oath. Students and staff donated food to the needy, and incoming students recited the Ephebic Oath as seniors pass on to them the torch of tradition and community service.

There are several new initiatives underway this year. Thanks to funding provided through the school budget and by our wonderful Alumni and Parent Teacher Associations, our television studio has been restored and is now in even better condition than when the current building opened in 1995. We have received \$150,000 in additional funding to complete our technology upgrade. We wish to acknowledge City Council members James Gennaro, John Liu and David Weprin for their generous support for educational improvements. We know

these improvements will place Townsend Harris High School at the forefront of state-of-the-art educational programs throughout the city.

For the second year, every New York City school is taking part in a Quality Review. The Quality Review ascertains how well schools use data to evaluate students, plan instruction and set goals on the classroom and school levels. Parents, students, teachers and administrators take part in this process. As members of the Townsend Harris community, you should be aware of my instructional focus. This year my instructional priorities are: writing across the curriculum, a focus upon the Essential Elements of Instruction, in particular instructional objectives and enhanced use of technology.

Finally, I would like to mention the outstanding efforts of the PTA and Alumni Association in supporting our educational program. They demonstrate that teamwork, organization, and effort are instrumental in providing quality programs for all students.

I look forward to another rewarding school year and hope to see you at alumni and school events.

# THE DAWN OF A NEW GOVERNMENT

#### MY PERSONAL ACCOUNT

The evening call to prayer is still drifting across the air. From my rooftop perch, the closest minaret serves to provide perspective for the mountains in the background which ring Kabul.

Kites fly in the air over my head, a reminder that the Taliban are no more — those religious disciples who brought peace as well as terror to Afghanistan, and whose interpretation of Islam could find no room for kites, beardless men, or women's faces.

The neighborhood that I live in, Shash Darak, was the front line during the civil war that decimated Kabul in the 1990's. Nothing much was left here. The military compound that neighbors my house is first being repaired this summer. The bullet pock-marked walls are being smoothed over, the rubble that had been there cleared away in two nights to make way for a new military hospital.

Beyond that compound is the Kabul River, which flowed again recently for the first time in five years, ending a drought which had been the cap to almost three decades of horror for the people of Afghanistan. The more optimistic and philosophically minded might consider this a sign that the new rulers of Afghanistan have acquired the mandate of heaven.

And indeed, there are new rulers in Afghanistan. Last September brought these people the first democratically elected president they have had in decades. This September, Afghans will be electing a new national assembly along with provincial councils. Once these elections are com-

plete, the constitutional government of Afghanistan will be more or less complete, and this will, at least in the legal sense, cease being a nation in transition.

My job is to help midwife the birth of this new government in this ancient land. It is, in some sense at least, a bizarre task. This is a place where the capital city does not have clean drinking water, where home toilets empty onto the sidewalks (for those who can afford sidewalks and toilets), where illiteracy is the norm, and where \$500 a month is an enviable salary.

Some would say that democracy is far down the list of these people's needs. I think not.

Right now, I am the head of the Election Complaints Commission Secretariat, the quasi-judicial body set up to deal with complaints arising out of the electoral process. So far, the Commission has received over 2,500 complaints, many

having nothing to do with the electoral process, at least in the legal sense.

A huge number of these complaints have to do with the terror that the complainants say the local warlords, the people who have held the real power in Afghanistan for quite some time, have been inflicting on the their fellow citizens. I have seen

pictures of and read descriptions of eyes gouged out, tongues cut, families murdered, rapes, beatings, gun battles with police, drug smuggling, human trafficking, and the list goes on.

The people who do this can get away with their crimes because they are unaccountable to their fellow citizens. Democracy doesn't guarantee good government, but what it does do is make the government accountable to the people.

While it is true that someone who has died of cholera because there is no clean water has no need of democracy, it is also true that someone who has been tortured and murdered by an unaccountable warlord has no need of clean water.

Democracy and accountable government is not something which should be shoved to the back burner because of other social ills; poverty, disease, and illiteracy do not justify taking away a persons



right to choose who will govern, nor does it absolve a person of the duty to do so.

These elections are not the first in which I have been lucky enough to play an important part. I have worked on this year's Iraq elections, several elections in Kosovo, and I have observed elections in Macedonia and Azerbaijan. What is almost uniformly true about all of these elections is the measure of hope that the participants bring to the process. They truly believe that they can change their

lives by voting and by participating in the electoral process, something that we in America have seemingly forgotten.

This hope is what makes democracy a superior system. While it may have the flaws of cronyism, corruption, and inefficiency like other systems, there is always the possibility that the people, on their own initiative, can change the system. Like Pandora's Box, inside the box of democracy, hidden away under all the flaws we know are there, unnoticed at the very bottom, is the hope that change can occur, the hope that a people can build a better life for their children and grand-children. It is my job to help bring this hope to people, and I feel truly privileged to have the opportunity to do it.

The official Annual Meeting business was conducted quickly and smoothly, and the Directors were elected without dissent. The head of the fund raising program was able to announce a dramatic gift to the Alumni Association of more the a million dollars in stock from Dr. Leonard Polonsky '43.

Philanthropist Eugene M.Lang '34, a recipient of the Presidential Medal of Freedom, gave a brief talk about the link between social responsibility and formal education. He reported on the progress that is being made by Project Pericles, a program designed to prepare college students for active participation in a pluralistic society in which citizenship, social responsibility, and community service are inseparable. Next, in a similar vein, there was a panel discussion on the meaning of a Humanities Education in the 21st Century. The panel was led by THAA co-President Tanya

M. Odom '88 and included founding principal Malcolm Largmann, longtime faculty members Harry Rattien and Franco Scardino, New York Times reporter David Herszenhorn '90 and NYC Department of Education Chief Family Engagement Officer Martine Guerrier '89. Questions discussed included "How does Townsend Harris maintain its status as the premier Humanities school in the country?", "What tools do today's students need to succeed in the 21st Century?" and "What role can alumni and parents play in a Humanities education?" When the panel discussion was completed, Ms. Odom invited questions from the audience.

This first meeting in Manhattan was successful in every way. It is hoped that if a similar program is undertaken next year, even more younger alumni will attend. Our thanks go to Craig Slutzkin '91 and Tanya Odom '88, co-Presidents of the Alumni Association for the effort, planning and hard work that went into this project. And very special thanks goes to Margherita Wischerth, THHS faculty member and THAA Administrator, for her assistance in organizing this event.

ver the past two years, Townsend Harris lost many members of its alumni family. Our Florida chapter lost four longtime Board members — Al Feld '40, Harold Jaffa '40, Norman Packer '35 and Henry Scheier '32.

Below find obituaries of a few of our fellow classmates and friends:

#### David Aronoff, 81, Class of 1942

The first name in April 5th's New York Times obituary list is my classmate and friend David Aronoff '42. He died of cancer on April 4th. Dave was a remarkable guy, probably the finest swimmer to ever attend Townsend Harris, and still playing tennis at 81. Although he was a so-so student in his Harris days, he became a true intellectual in his later years. He continued to take college courses until the very end of his life, expanding his mind and satisfying his curiosity. It always impressed me that he studied Italian so that he could read Italian literature in its original form. It didn't seem pretentious or artificial when he mentioned to me one day how much he enjoyed reading Ovid's poetry. (In translation, in this case.)

Dave was personable, kind, generous and thoughtful — a straight talker who spoke from the heart but was careful not to offend. A very private person, I don't know if he had any very close friends, but I know I cherished him as a dear friend. At our 1942 Commencement ceremonies, Dave was awarded two medals relating to strength of character. They sure had that right.

#### Louis Elbaum, 95, Class of 1928

Louis Elbaum, a New York businessman, passed away in Miami, FL, Tuesday October 23, 2007, at the age of 95. Mr. Elbaum was born in New York City, where he attended Townsend Harris High School and New York City College. He received his JD degree from Brooklyn Law School and was admitted to the New York Bar in 1941. During World War II, Mr. Elbaum served in the U.S. Army Air Corps as an instructor in radio mechanics. He married Esther Hianny,

of Milwaukee, in 1944. Mr. Elbaum was the proprietor of Nelson's Embroidery, a business specializing in custom quilts and embroidery. He was a life member of Friends of Na'amat.

#### Edward Hall, 91, Class of 1931

Col. Edward N. Hall, an engineer who as an intelligence officer scrutinized the V-2 rockets of Nazi Germany and went on to supervise programs leading to the development of the United States' intercontinental ballistic missiles, including the Minuteman, died on Jan. 15, 2006 in Torrance, Calif. He was 91.

As relations with the Soviet Union rapidly deteriorated after World War II, fears surged in the American military that the Russians were gaining superiority in missile technology. As hundreds of millions of dollars were poured into a crash program to jump-start the American effort, Colonel Hall emerged as a technical leader, particularly in the rush to develop rockets using solid, not liquid fuel.

His result was the Minuteman, the first 10 of which were installed in nearly impregnable underground silos in October 1962 during the Cuban missile crisis. Ultimately 1,000 were positioned in hidden locations in the Midwest.

In 1999, J. D. Hunley, an Air Force historian, wrote that even considering the technical complexity of weapons programs, where assigning individual credit is exceedingly difficult, Colonel Hall was "pivotal to the development" of the missile.

At the time of the Minuteman project, Colonel Hall had already led development of some of the principal liquid-fuel missiles, the Atlas, Titan and Thor.

Edward Nathaniel Hall was born in Forest Hills, Queens, on Aug. 4, 1914. He was the son of a furrier who went bankrupt in the Depression, but he was able to attend the City College of New York, which was then free, where he earned undergraduate and master's degrees in chemical engineering. Later, while in the Air Force, he earned a master's degree in aeronautical engineering (propulsion option) from the California Institute of Technology.

In September 1939, as war was beginning in Europe, he joined the Army Air Corps as an enlisted man. He was sent to England to repair Boeing B-17 bombers and Martin B-24's, both used in the bombing of Germany. In 1943, as a captain, he was awarded the Legion of Merit, an unusual award for a junior officer, for devising a way to repair a bomber's fuselage rapidly.

His introduction to missiles came near the end of the war, when he was assigned to acquire intelligence on Germany's wartime propulsion work. He analyzed parts recovered from exploded V-2 rockets or retrieved by spies.

At war's end, he led a group to Germany to study underground missile assembly facilities at Camp Dora. He assisted in the division of captured missile equipment between England and the United States.

After a second European tour, he was stationed at what is now Wright-Patterson Air Force Base in Ohio to work on a variety of rockets, including the Bomarc, Navaho, Snark, Rascal and Falcon. In 1951, he was a leading instigator of what became the Atlas program.

From November 1953 to February 1954, Colonel Hall served as Wright's representative at meetings of the Air Force group, overseeing ICBM development, popularly known as the Teapot Committee. In August 1954, he moved to Los Angeles.

He retired in 1959, and the next year won a second Legion of Merit. He worked for the United Aircraft Corporation and several other firms, and in 1999 was elected to the Air Force Space and Missile Hall of Fame.

In addition to his daughter, who lives in Calabasas, Calif., Colonel Hall was survived by his wife of 62 years, the former Edith Shawcross, and his sons, David, of La Crescenta, Calif., and Jonathan, of Kendall Park, N.J.



#### Monroe Inker, 80, Class of 1942

From the *Boston Herald*, Tuesday, April 18, 2006:

Monroe Inker of Newton, a lawyer, teacher and author, died Saturday of

heart failure at his home. He was 80.

Born in Boston, Mr. Inker grew up in Brighton Beach, N.Y., where he attended Townsend Harris High School. He later attended Harvard Law School on the GI Bill.

He began his law career as a criminal defense lawyer before moving into family law in the 1960s. His advocacy for women's rights and child welfare led to the passage of no-fault divorce and equitable division of marital assets statute in 1975.

As a young man, Mr. Inker taught at Harvard and Northeastern University Law School. Later, he taught at Boston College and Suffolk Law School. He and Charles Kindregan co-wrote the four-volume Massachusetts Practice Books on Family Law, now in its fourth edition. He also co-wrote an annual paperback on domestic relations rules.

Mr. Inker was survived by his wife of 46 years, Elaine; two daughters, Lauren of Needham and Rachel of Jericho, VT; four grandchildren and a niece.

#### Boris Kostelanetz, 94, Class of 1928

Boris Kostelanetz, considered the dean of tax defense lawyers, died in early 2006 at St. Vincent's Hospital near his home in Manhattan. He was 94.

Mr. Kostelanetz, a founding partner of Kostelanetz & Fink, handled the defense in tax evasion cases for scores of well-known clients like Imelda Marcos and James Brown. But he made his own name as a tenacious federal prosecutor who took on organized crime.

As a special assistant to the United States attorney general in 1939, Mr. Kostelanetz helped expose the Mafia's ties to the movie industry. He went on to prosecute several organized crime figures who had infiltrated the International Alliance of Theatrical and Stage Employees and extorted huge sums of money from Hollywood studios and neighborhood cinemas. That 1943 case was among the first to lead to convictions for murder, extortion and conspiracy directly under federal statutes, not state laws.

Soon afterward, Mr. Kostelanetz was appointed chief of the war frauds section of the Justice Department, which examined fiscal irregularities during World

War II. From 1951 to 1952, he served as special counsel to a United States Senate committee headed by Estes Kefauver. The televised hearings of the committee showed the extent to which Mafia figures had received special treatment from government officials.

Yet Mr. Kostelanetz always said he felt more at home as a courtroom advocate than an administrator on Capitol Hill. In 1946, he helped found the law firm that evolved into Kostelanetz & Fink, and he continued to show up at the office regularly until just before he died.

During his long career, Mr. Kostelanetz handled a heavy load of tax evasion cases. Among the clients he defended were Bobby Baker, a protégé of President Lyndon B. Johnson; Dr. W. Kenneth Riland, the physician to President Richard M. Nixon and Gov. Nelson A. Rockefeller; and Anthony Conrad, chairman of the RCA Corporation. His efforts were frequently successful.

Born in 1911 to a wealthy family in pre-revolution Russia, Mr. Kostelanetz and his family fled St. Petersburg and eventually arrived in New York when he was 9

In 1933, Mr. Kostelanetz joined Price Waterhouse as an accountant. But to stand out from his peers, he enrolled at St. John's University law school at night. Upon graduating from law school, he joined the United States attorney's office in New York, where his financial background made him the expert in prosecuting complex securities and tax crimes.

Mr. Kostelanetz was an adjunct professor of taxation at New York University, where he also served as a trustee. He was also president of the New York County Lawyer's Association and chairman of the character and fitness committee of the Appellate Division, which oversees the admission of lawyers to the bar.

Mr. Kostelanetz's wife, Ethel, died in 2002. In addition to his daughter, Mr. Kostelanetz is survived by a son, Richard, and a granddaughter.

#### Harold S. Lynton, 97, Class of 1925

Harold S. Lynton died at age 97 on June 11, 2007. Lynton was a former partner in the law firm of Shea & Gould and was Of Counsel to Dornbush Shaeffer Strongin & Venaglia. He specialized in corporate and tax law. Lynton, who was a graduate of the Class of 1925, attended Yale University and Harvard Law School and was a member of Phi Beta Kappa. He was mourned by his wife Hattie, sons Stephen and Dick, as well as his granddaughters.



#### David Mark, 81, Class of 1939

David Everett Mark was an American career diplomat.

Born in New York City to Leslie Mark, and Lena Tyor Mark, Mark graduated from Columbia University, and while serving in the Army Air Corps during World War II, he completed his studies at Columbia Law School. He joined the U.S. Foreign Service in 1946, serving in South Korea, Germany, Finland, Romania, and Moscow in the 1950s.

In the early 1960s, Mark served in various capacities in the "Intelligence and Research Bureau" until his appointment as Ambassador to Burundi from 1974 to 1977. From 1979 to 1981 he served again at the U.S. State Department as a deputy assistant Secretary of State. After retirement from government in 1981, he consulted on international affairs for ALCOA in Pittsburgh, Pennsylvania.

A gifted linguist, Mark spoke fluent Russian, German, and French, and was conversant in Portuguese, Spanish, Italian and Japanese. With the break-up of the Soviet Union in 1989 and the dearth of Russian linguists, Mark was asked to help establish the American Embassy in the former Soviet Republic of Georgia. He returned to Tbilisi in 1992 to participate in helping the Georgians write their Constitution.

During the 1990s until his death, Mark was an active member of the Council on Foreign Relations in New York City. He volunteered every week for nine years as a guide and translator for Big Apple Greeters of New York. He worked full time as a licensed New York City tour guide for Gray Line/ CoachUSA, sharing his love for the city with thousands of tourists each year in any number of the languages he spoke. Mark taught a variety of courses as an

adjunct professor of global affairs at New York University.

Mark, 81, died in 2005 while on vacation in northern Montana.



#### Maurice Paprin, 85, Class of 1936

Maurice Paprin, a real estate entrepreneur who built thousands of apartments in New York and spent decades promoting liberal causes, died on November 25, 2005 at a hospital in Manhattan. He was 85.

Born in the Bronx, Mr. Paprin got his start building single-family homes in the 1960s and went on to build, buy and manage large apartment buildings and subsidized housing complexes throughout the city.

While he made his fortune in business, Mr. Paprin was busy as an activist. He protested U.S. wars, bought newspaper advertisements calling President Clinton's impeachment an "obscene circus" and founded a nonprofit called the Fund for New Priorities.

The group organized forums on issues ranging from the plight of the U.S. farmer and Watergate to the ouster of President Ferdinand Marcos in the Philippines.

Mr. Paprin also served as chairman of the Business, Labor and Community Coalition of New York and was president of Associated Builders and Owners of Greater New York for 14 years.

Mr. Paprin served on the Townsend Harris Alumni Association Board of Directors for many years and was a Vice President of the Board for several of them.

He was survived by his wife, Jacqueline Paprin, his sons Seth, Yale and Frederick, a daughter, Judith, and stepsons Steven and Miles Stuchin.



#### Gilbert Perlow, 91, Class of 1932

Gilbert Perlow, one of the pioneers of the Mössbauer effect and an editor of the Journal of Applied Physics and Applied Physics Letters died on February 17, 2007, a week after his 91st birthday.

He was born in New York City on February 10, 1916. Gil went to Cornell in 1932 as an undergraduate at age 16 to study medicine, as his parents saw this as a good career during the Depression. But so strong was his interest in physics (and, as he said, his talent for medicine was not so great) that he switched. He went on to graduate work at Cornell, and his Masters thesis was on measurements of satellite x-rays was supervised by F. K. Richtmyer. He then moved to the University of Chicago and did his Ph.D. thesis research with S. K. Allison on nuclear reactions of 6Li using a Van de Graaf accelerator. For assistance with making a lithium target he consulted a chemist, Mina Rea Jones, who became his wife as well as scientific partner until she died in 2003.

Gil's Ph. D. thesis was completed in 1940. With America's involvement in World War II approaching, he left Chicago for the Naval Research Laboratory in Washington DC, where he worked on submarine detection using ultrasound. The system he built was so successful, that he was flown to Pearl Harbor to supervise its installation in a submarine. After the war he turned to cosmic ray measurements in the upper atmosphere using captured German V2 rockets. He designed and built several detector systems that were launched from White Sands, New Mexico.

In 1952 Gil joined the faculty of the University of Minnesota and in 1954 he moved to Argonne National Laboratory where, apart from sabbaticals at Harwell and Munich (where he was the recipient of a Humboldt Fellowship), he spent the rest of his career.

Gil had always believed in the importance of looking for applications of research and in communicating and disseminating the results of research (and indeed held a patent for using the Mössbauer Effect to measure y-ray polarization). He became Editor of both the Journal of Applied Physics and Applied Physics Letters in 1970. He retired from the Physics Division at Argonne in 1981, but remained an important influence in the AIP's physics journals office at Argonne until he finally retired in 1990. He was an inventive editor, and instituted a high-Tc panel when these materials were discovered, assuring rapid publication and APL's share in this exploding field. Following the example of Reviews of Modern Physics he established Applied Physics Reviews. He wrote many of the form letters still used and his ad hoc correspondence was a delight to read. His constant support was highly appreciated by his successors.

A witty and cultured man, he enjoyed reading, sketching, listening to music and sailing his yacht on Lake Michigan. He served as Commodore of the Chicago Corinthian Yacht Club.
